Strained state budget resources

 Medicare Beneficiaries with Chronic Diseases



- 26% Functionally Impaired
- 95% Medicare \$ Related to Chronic Conditions



- Greater functionality with chronic conditions
- Living longer, yet sicker
- Bottom Line: necessity of high quality coordinated care!

Work Force Dilemma

- Increased demand
- Constricted supply
- Falling unemployment
- Low compensation direct care workers 70% funded by government programs



The dichotomy:



We want safety for those we love and we want autonomy for ourselves.

DIMENSION	KEY QUESTIONS
Reach	Is the program serving a priority population? What is need in their community?
E ffectiveness	Does the program impact Quality of life, health Nursing home placements Caregiver capacity Hospital readmissions
A doption	Are service providers fully engaged? Are consumers creating/using plans?
I mplementation	Is the program delivered as intended?
Maintenance	Can/should the program be sustained? Does the impact last?
